INSTRUCTIONS AND REMINDERS TO PROPOSER AND SECONDER

1. Sponsor and Seconder must be Voting Members, (i.e. Playing Members in good standing except Junior Members) and must have been Voting Members for at least two years. Junior candidates need only one of the two sponsors to be a Voting Member.
2. A couple cannot be both Sponsor and Seconder for the same candidate.
3. A Voting Member cannot propose or second more than six candidates each year.
4. Sponsor and Seconder are each required under separate cover, **TO WRITE A LETTER** to the Honorary Secretary giving specific reasons why the candidate should be considered favorably for membership. These letters are considered to be **VERY IMPORTANT PART OF THE APPLICATION FOR MEMBERSHIP**, and the application will not be considered without them. A sponsor is responsible for submitting to the Honorary Secretary the completed application together with the supporting letters.
